



# Average commercial energy storage price per 100kW in Ireland

Can a 100 kW solar system be used in Ireland?

Yes, businesses in Ireland can benefit from the SEAI (Sustainable Energy Authority of Ireland) grant, which can significantly reduce the cost of a 100 KW solar system installation. Grants of up to EUR22,600 are available. Can I sell excess electricity from my 100 KW solar system back to the grid?

What is Ireland doing about energy cost competitiveness?

Ireland has committed to developing metrics of energy cost competitiveness as outlined in the Government's White Paper on Ireland's Transition to a Low Carbon Energy Future 2015-2030. We have developed average electricity and natural gas prices for business and households. These are based on the EU Electricity and Gas Price Regulation statistics.

Why are electricity costs so high in Ireland?

Our network costs are similar to those of other Member States. The relatively high price of our electricity in Ireland is attributed to our dependence on imported fossil fuels, particularly gas, and the costs of generation and supply, although transmission and distribution costs have increased year on year with greater investment.

What are the average gas and electricity prices in Ireland?

For the first half of 2023, the average commercial electricity price in Ireland was 27.29 Euro cents per kWh. Regarding gas, the average price for businesses during the same period was 8.02 Euro cents per kWh.

How much does energy storage cost?
